What data we collect

The data we collect from you may include:

- Questions, queries or feedback you leave, including your email address.
- Your email address and subscription preferences when you sign up to our email alerts.
- Your name, your company name and phone number
- How you use our emails - for example whether you open them, and which links you click on

Why we need your data

We may collect information to monitor how you use the website. We do this to help:

- Make sure the site is meeting the needs of its users.
- Make improvements, for example improving site search.

We also collect data to:

- Respond to any feedback you send us, if you've asked us to
- Send email alerts and newsletters to users who request them.
- Provide you with information about products and services if you want it.
- Monitor use of the site to identify security threats.

The legal basis for processing personal data in relation to site security of the domain www.cetix.co.uk is our legitimate interest, and the legitimate interest of users.

What we do with your data

The data we collect will not be sold or rented to third parties. Nor will it be shared with third parties for marketing purposes

We will share your data if we are required to do so by law – for example, by court order, or to prevent fraud or other crime.

How long we keep your data

We will only retain your personal data for as long as it is needed for the purposes set out in this document or the law requires us to. We will keep your email data until you unsubscribe.

Children's privacy protection

Our services are not designed for, or intentionally targeted at, children 13 years of age or younger. We do not intentionally collect or maintain data about anyone under the age of 13.

Where your data is processed and stored

We will ensure that your data remains secure, both while it's processed and when it's stored either within the company or by external hosted services.

How we protect your data and keep it secure

We are committed to doing all that we can to keep your data secure. We have set up systems and processes to prevent unauthorised access or disclosure of your data. We also make sure that any third parties that we deal with keep all personal data they process on our behalf secure.

Your rights

You have the right to request:

You can also:
